## SECOND VIOLATION NOTICE

On July 21, 2014, the Department of Environmental Quality (DEQ), Air Quality Division (AQD), conducted an inspection of Stress-Con Indutries (Facility), located at 3102 East Cork Street, Kalamazoo, Michigan.

The purpose of the inspection was to determine the Facility's compliance with the requirements of the federal Clean Air Act; and Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (Act 451); the administrative rules; and the conditions of Permit to Install (PTI) No. 401-75 and 380-78.

On July 25, 2014, the AQD sent the Facility a Violation Notice citing a violation discovered as a result of the inspection and requested your written response by August 13, 2014. A copy of that letter is enclosed for your reference. As of this date, we have not received your response.

In addition, after leaving the Facility they began operation. What appeared to be a cloud of dust coming from the west side of the concrete plant was noticed. What was/is the cause of this cloud of dust? What has been/will be done to correct the cloud?

On July 22, 2014, via email, the name and address of the crushing company that has been hired to crush your scrap concrete was requested. If you have not responded to that email as of the date of your response to this letter, please include that information in your response.

Please be advised that failure to respond in writing and identifying actions the Facility will take or has taken to resolve the cited violation may result in escalated enforcement action by the AQD. Please provide the information requested in our August 13, 2014, letter by September 5, 2014, which corresponds to 14 days from the date of this letter.

Be further advised that issuance of this Violation Notice does not preclude or limit the DEQ's ability to initiate any other enforcement action under state or federal law as appropriate.
