VIOLATION NOTICE

On December 1, 2015, the Department of Environmental Quality (DEQ), Air Quality Division (AQD), conducted an inspection of Rogers Printing Inc. located at 3350 Main Street, Ravenna, Michigan. The purpose of this inspection was to determine Rogers Printing Inc.'s compliance with the requirements of the federal Clean Air Act; Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (Act 451); the administrative rules; the conditions of Permit to Install (PTI) number 114-01C; and Consent Order AQD No. 29-2013.

During the inspection, staff observed the following:

Process Description	Rule/Permit Condition Violated	Comments
FGOFFSET2	PTI No. 114-01C, Special Condition (SC) VI.4	Failure to maintain RTO temperature records from July 21, 2015 through September 27, 2015.

During this inspection, Rogers Printing Inc. was unable to produce RTO temperature records. This is a violation of the recordkeeping requirements specified in SC VI.4 of PTI No. 114-01C. The conditions of PTI No. 114-01C require maintenance of records, which shall be made available for review upon request by the AQD staff.

Please initiate actions necessary to correct the cited violation and submit a written response to this Violation Notice by January 8, 2016 (which coincides with 21 calendar days from the date of this letter). The written response should include: the dates the violation occurred; an explanation of the causes and duration of the violation; whether the violation is ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violation and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence.
