VIOLATION NOTICE

On July 29, 2015, the Department of Environmental Quality (DEQ), Air Quality Division (AQD), conducted an inspection of Cadillac Casting, Inc. located at 1500 Fourth Avenue, Cadillac, Michigan. The purpose of this inspection was to determine Cadillac Casting, Inc.'s compliance with the requirements of the federal Clean Air Act; Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (Act 451); the administrative rules and the conditions of Renewable Operating Permit (ROP) number MI-ROP-B2178-2014.

During the inspection, staff observed the following:

Process Description	Rule/Permit Condition Violated	Comments
Desulphurization ladle located in EUMELTING	Condition III.2; Rule 910	The desulphurization ladle was operating during periods in which the baghouse differential pressure was outside of the range specified in the ROP for the time period September 1, 2014 to August 31, 2015.
EUMELTING	Conditions VII.2 and 3	Operation of the desulphurization ladle during periods in which the baghouse differential pressure was out-of-range was not reported in the semiannual deviation report and annual certification of compliance.

Please initiate actions necessary to correct the cited violations and submit a written response to this Violation Notice by October 9, 2015. The written response should include: the dates the violations occurred; an explanation of the causes and duration of the violations; whether the violations are ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violations and the dates by

which these actions will take place; and what steps are being taken to prevent a reoccurrence.

If Cadillac Casting believes the above observations or statements are inaccurate or do not constitute violations of the applicable legal requirements cited, please provide appropriate factual information to explain your position.

Thank you for your attention to resolving the violation cited above and for the cooperation that was extended to AQD staff during during inspection of Cadillac Casting.
