**VIOLATION NOTICE**

On May 3, 2016, the Department of Environmental Quality (DEQ), Air Quality Division (AQD), conducted an inspection of Cadillac Asphalt LLC, located at 4751 White Lake Road, Clarkston, Michigan. The purpose of this inspection was to determine Cadillac Asphalt's compliance with the requirements of the federal Clean Air Act; Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended; the administrative rules; and the conditions of Permit to Install (PTI) No. 443-82H.

During the inspection, staff of the AQD observed the following:

Process Description	Rule/Permit Condition Violated	Comments
EUHMAPLANT	Special Condition 1.18 of PTI No. 443-82H - Record one data set (eight separate readings over 30 minutes or longer) from the carbon monoxide (CO) monitor upon the start-up of each paving season.	Records submitted by the Cadillac Asphalt indicate a complete data set of CO readings was not recorded at the start-up of the 2016 paving season.

Please initiate actions necessary to correct the cited violation and submit a written response to this Violation Notice by July 28, 2016 (which coincides with 21 calendar days from the date of this letter). The written response should include: the dates the violation occurred; an explanation of the causes and duration of the violation; whether the violation is ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violation and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence.
