## Summary of Facility Visit and Compliance Status:

Air Quality Division (AQD) records on file indicates a business by the name of U.S. Auto Radiator Manufacturing Corporation in operation at 221 Victor, Highland Park, Michigan, 48203. Wayne County Installation Permit C-6955 was issued to this address for the installation of an auto radiator flux spray and bake oven. The business name and the associated address were not identified in AQD's Detroit Database.

According to the State of Michigan's Business Entity Search (compiled by the Department of Licensing and Regulatory Affairs [LARA]), U.S. Auto Radiator Manufacturing Corporation underwent automatic withdrawal on July 15, 1998.

On January 14, 2014 Mr. Todd Zynda arrived at 2:00 PM in the area of 221 Victor. U.S. Auto Radiator Manufacturing Corporation is no longer in operation at this location. Currently, Micro RIM operates at the address. According to Mr. Larry Weiss, Warehouse Manager, Micro RIM purchased the property at 221 Victor in 1990. At that time the building was vacant and the auto radiator flux spray and bake oven was removed. Micro RIM specializes in class-A paintable plastic molding of prototype and production parts. Micro RIM currently operates two reaction injection molding presses at this location. Reaction injection molding operations at Micro RIM are exempt from permit to install (PTI) requirements under Rule 286(e).

R 336.1286(e) - The requirement to obtain a permit to install does not apply to reaction injection molding (open or closed mold) and slabstock/casting equipment.

The remaining space at 221 Victor is used for storage and distribution of molded parts. Primary manufacturing for Micro RIM is conducted out of the facility located in Warren, Michigan.

Wayne County Installation Permit C-6955 will be voided. A void letter will not be issued as U.S. Auto Radiator Manufacturing Corporation is no longer an active company and is not operating at 221 Victor. Micro RIM appears to be in compliance with federal and state air quality regulations.
