**SECOND VIOLATION NOTICE**

On May 21, 2020 and August 14, 2020, the Department of Environment, Great Lakes, and Energy (EGLE), Air Quality Division (AQD), conducted an annual and follow up inspection of Michigan Cleaners (Company), located at 2300 West Stadium Boulevard, Ann Arbor, Michigan. The purpose of the inspections was to determine the Company's compliance with the requirements of the federal Clean Air Act; Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended; and the Air Pollution Control Rules.

On September 11, 2020, the AQD sent the Company a Violation Notice (VN) citing violations of the Public Health Code, 1978 PA 368, as amended, Dry Cleaning Establishment Rules Utilizing Class I, II, III, and IV Solvents, specifically, R 325.17302 (2) and (4) for failing to pay \$54.19 for the 2019 Dry Clean License fee and for failing to pay the 2020 Dry Clean License fee. Additionally, the Company was cited for failing to pay the Category III Air Quality fees for 2020. These violations were discovered because of the inspection and requested the Company's written response by October 2, 2020. A copy of this VN has been enclosed for your reference. As of the date of this letter, the AQD has not received the Company's written response to the cited violations.

Please be advised that failure to respond in writing and identifying actions the Company will take or has taken to resolve the cited violations may result in an escalated enforcement action by the AQD. Please provide the information requested in the VN dated September 11, 2020 by **November 13, 2020**, which corresponds to 14 days from the date of this letter.

The Company's written response must be submitted to Mr. Jong Yu, at EGLE, AQD, 525 West Allegan Street, Lansing, Michigan 48909 and must include a copy to Ms. Jenine Camilleri, Enforcement Unit Supervisor at EGLE, AQD, P.O. Box 30260, Lansing, Michigan 48909-7760.
