It shows that VOC emissions are predominantly fugitive emissions from valves (52% of the total VOC emissions), relief valves (22.5%) and flanges/connectors ((18.5%) .The rest are minor emissions from LPG Loading Rack and other miscellaneous. NOX and CO are emitted in insignificant proportions from relief valves and from projects related flaring. The emissions this year are very similar to the last year's emissions
