VIOLATION NOTICE

On October 18, 2019, the Department of Environment, Great Lakes, and Energy (EGLE), Air Quality Division (AQD), conducted a records review of Viant Medical, Inc. located at 520 Watson, S.W., Grand Rapids, Michigan. The purpose of this records review was to determine Viant Medical, Inc.'s compliance with the requirements of the federal Clean Air Act; Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (Act 451); the Air Pollution Control Rules; and the conditions of Permit to Install (PTI) Number 605-89B.

During the records review, staff observed the following:

Process Description	Rule/Permit Condition Violated	Comments
Ethylene Oxide Sterilization Process EU-ETOSTERILIZERS	Rule 910	Failure to properly maintain air pollution control equipment.

On October 18, 2019, AQD staff received copies of maintenance records that are required to be maintained by PTI No. 605-05B. A review of this information found that a malfunction of the control device was discovered on July 11, 2019. This malfunction consisted of the failure of a carbon steel plug allowing a small leak.

This constitutes a violation of Rule 910 of the administrative rules promulgated under Act 451, which requires that an air-cleaning device shall be installed, maintained, and operated in a satisfactory manner and in accordance with the administrative rules and existing law.

Please initiate actions necessary to correct the cited violation and submit a written response to this Violation Notice by November 12, 2019. The written response should include: the dates the violation occurred; an explanation of the causes and duration of the violation; whether the violation is ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violation and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence.


