VIOLATION NOTICE

On June 1, 2016, the Department of Environmental Quality (DEQ), Air Quality Division (AQD), conducted an inspection of Denso Manufacturing Michigan, Inc. (Denso), located at One Denso Road, Battle Creek, Michigan. The purpose of this inspection was to determine Denso's compliance with the requirements of the federal Clean Air Act; Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (Act 451); the administrative rules; and the conditions of Permit to Install (PTI) No. 174-05, 296-03A, 70-07, 192-04A, 98-03B, 7-06E, 19-04B, 190-14, 277-04E, 68-03B, 327-08A, 267-07B, and 48-15C; and the conditions of Renewable Operating Permit (ROP) No. MI-ROP-N1192-2003B.

During the inspection, staff of the AQD observed the following:

Process Description	Rule/Permit Condition Violated	Comments
EU-HTR1	PTI No. 19-04B, Special Condition IV.1	The thermal oxidizer associated with oven degreaser H451 was operating at a combustion temperature of 1328 degrees F (720 degrees C) versus a required minimum combustion temperature of 1400 degrees F (760 degrees C).

Please initiate actions necessary to correct the cited violation and submit a written response to this Violation Notice by June 30, 2016 (which coincides with 21 calendar days from the date of this letter). The written response should include: the dates the violation occurred; an explanation of the causes and duration of the violation; whether the violation is ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violation and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence.
