On November 13, 2015, AQD staff Kerry Kelly conducted a targeted inspection at Cheyenne Express Trucking located at 46850 Grand River, Novi, Michigan. This facility is identified by the Air Quality Division with the State Registration Number N1427. The purpose of this inspection was to determine the facility's compliance with the requirements of the Federal Clean Air Act; Article II, Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (Act 451); and Michigan's Air Pollution Control Rules.

#### FACILITY OVERVIEW

The address where Cheyenne Express Trucking is located, 46850 Grand River, Novi, Michigan, was previously occupied by Tony Angelo Cement Construction Company. Permit to Install (PTI) 572-86G was issued to Tony Angelo Cement Construction Company on July 27, 1992 for a portable concrete batch plant located at this address. PTI 572-86G was voided on April 18, 2012. According to the State of Michigan, Department of Licensing and Regulatory Affairs, Tony Angelo Cement Construction Company located at 46850 Grand River in Novi, Michigan, was listed as dissolved on April 1, 2009 and automatically dissolved on July 15, 2014. In July 2014, Cheyenne Express Trucking began leasing the property from Tony Angelo Cement Company.

#### INSPECTION

Ms. Kelly entered the site, presented her DEQ employee photo identification, explained the purpose of the inspection, and gave a copy of the pamphlet "Environmental Inspections: Rights and Responsibilities" to Mr. James Drummond, Manager. Mr. Drummond accompanied Ms. Kelly on the inspection.

Currently, there is an office building, a maintenance garage and a parking lot with gas pumps on the property. AQD staff did not observe any cement process equipment on the premises of Cheyenne Express Trucking. Mr. Drummond said there was no generator or boiler on the property. During the inspection AQD staff did not observe any boilers or generators. Ms. Kelly inspected the maintenance garage and observed a cold cleaner that Mr. Drummond said was not being used. The lid to the cleaner was closed and Ms. Kelly gave Mr. Drummond operating procedures for the cold cleaner. According to Mr. Drummond, Cheyenne Express Trucking is not using the gas pumps in the parking lot.

#### CONCLUSION

Cheyenne Express Trucking appears to be operating in compliance with air quality regulations.
