VIOLATION NOTICE

On January 8, 2014, the Department of Environmental Quality (DEQ), Air Quality Division (AQD), conducted an inspection of Benteler Automotive (Facility), located at 9000 East Michigan Avenue, Galesburg, Michigan. The purpose of this inspection was to determine the Facility's compliance with the requirements of the federal Clean Air Act; Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (Act 451); the administrative rules; and the conditions of Permit to Install (PTI) Nos. 31-01 and 249-10.

During the inspection, staff of the AQD observed the following:

Process Description	Rule/Permit Condition Violated	Comments
FG-Source	PTI No. 31-01, Condition I.1	The Facility is not keeping the sourcewide total volatile organic compounds emission calculations.
FG-Coating	PTI No. 31-01, Condition VIII.1	Stack height is not 1.5 times the building height.
EU-001	PTI No. 249-10, Condition VII.1 and 2	The Facility did not submit any of the required reports.


Please initiate actions necessary to correct the cited violations and submit a written response to this Violation Notice by February 11, 2014 (which coincides with 21 calendar days from the date of this letter). The written response should include: the dates the violations occurred; an explanation of the causes and duration of the violations; whether the violations are ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violations and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence.

If the Facility believes the above observations or statements are inaccurate or do not constitute violations of the applicable legal requirements cited, please provide appropriate factual information to explain your position.
