RESOLVED COMPLAINTS:

On August 9, 2021, the Michigan Department of Environment, Great Lakes and Energy-Air Quality Division (EGLE-AQD) staff, I (Shamim Ahammod) conducted a scheduled inspection of Messina Trucking Inc (SRN: N2613) located at 3295 Auburn Rd, Utica, Michigan. The purpose of the inspection was to determine the company's compliance with the requirements of the federal Clean Air Act; Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (Act 451); the Air Pollution Control Rules; and the conditions of General Permit to Install (PTI) No. 831-90 for a non-metallic mineral crusher and its associated equipment.

## **Permit History**

On November 2, 1990, Permit to Install (PTI) No. 831-90 was issued for a non-metallic mineral crusher and its associated equipment.

Previous inspection, complaints, and violations

On August 30, 2016, AQD Inspector Mr. Tyler Salamasick conducted a fugitive dust complaint investigation. Based on his investigation reports, he did not observe any significant fugitive emissions during his visit.

## **Onsite Inspection**

On August 9, 2021, at 1.40 PM, I arrived at the facility located at 3295 Auburn Rd, Utica, Michigan. I did not observe any crusher at this location. I took some pictures and attached them to this report.

Via phone, I talked with Mr. Stephen Messina, Owner of Messina Trucking, Inc. Mr. Messina said, about 2 years ago they permanently closed the facility located at 3295 Auburn Rd, Utica, Michigan and are planning to develop and sell this property. They sold some of the crushing equipment permitted in 831-90 and are storing the rest (conveyors) at Juengel Road. The conveyors stored at Juengel Road are included in PTI 83-19. Mr. Messina will send a request to EGLE-AQD to void Permit No. 831-90.

## Conclusion

Based on the on-site inspection, and discussion with the owner, it is determined that Messina Trucking Inc (SRN: N2613) located at 3295 Auburn Rd, Utica, Michigan is no longer on this site. Hence, compliance with applicable requirements was not determined. Mr. Messina will send a request to EGLQ-AQD to void Permit No. 831-90.
