VIOLATION NOTICE

On June 8, 2017, the Department of Environmental Quality (DEQ), Air Quality Division (AQD), conducted an inspection of Woodworth, Inc. (Facility), located at 29753 M-60 East, Homer, Michigan. The purpose of this inspection was to determine the Facility's compliance with the requirements of the federal Clean Air Act; Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (Act 451); the Air Pollution Control Rules; and the conditions of Permit to Install (PTI) No. 64-15A, 144-14, and 145-14.

Based on information obtained following the inspection, the Facility is in violation of the following:

Please initiate actions necessary to correct the cited violation and submit a written response to this Violation Notice by July 18, 2017 (which coincides with 21 calendar days from the date of this letter). The written response should include: the dates the violation occurred; an explanation of the causes and duration of the violation; whether the violation is ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violation and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence.

If the Facility believes the above observations or statements are inaccurate or do not constitute violations of the applicable legal requirements cited, please provide appropriate factual information to explain your position.
