**VIOLATION NOTICE**

On September 7, 2017, the Department of Environmental Quality (DEQ), Air Quality Division (AQD), was informed of a complaint concerning crushing activity located at Star of the West - Richville, 3269 South VanBuren Road, Reese, Michigan. The DEQ, AQD was asked by another Division to determine the activities' compliance with the requirements of the federal Clean Air Act; Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (Act 451); the Air Pollution Control Rules; and the conditions of Permit to Install (PTI) number 453-99;

During the review, staff discovered the following:

Process Description	Rule/Permit Condition Violated	Comments
Concrete Crushing	PTI 453-99 SC V.5.c	The crusher was located closer than 500 ft to the nearest residences and commercial establishments.


Please initiate actions necessary to correct the cited violation and submit a written response to this Violation Notice by October 3, 2017 (which coincides with 21 calendar days from the date of this letter). The written response should include: the dates the violation occurred; an explanation of the causes and duration of the violation; whether the violation is ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violation and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence.

If Hanlee Equipment believes the above observations or statements are inaccurate or do not constitute violations of the applicable legal requirements cited, please provide appropriate factual information to explain your position.
