Inspection Summary

This site identified by the RRD spill database as Facility ID 00005002 and Leak ID C-0196-95 and was showing as a "open" site with an active air permit. I was unable to find a contact person for the permit, so I performed a site visit to confirm the equipment had been removed and I could void the permit.

I visited the location on 3/4/16, the site is a Marathon gas Station / convenience store. Krystal spoke with me and stated that the device had been removed. She allowed a worker to take me to the building where the device was located and I confirmed that a remediation device was no longer on the property.

This report will be used to void Permit To Install 338-97. A copy of the voided permit will be sent to the McPherson Oil Company office located at 124 Grand River Avenue, Howell, MI 48844.
