**VIOLATION NOTICE**

Dear Mr. Crow:

On September 17, 2019, the Department of Environment, Great Lakes, and Energy (EGLE), Air Quality Division (AQD), conducted an inspection of Leland International located at 5695 Eagle Drive SE in Kentwood, Michigan. The purpose of this inspection was to determine Leland International's compliance with the requirements of the federal Clean Air Act; Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (Act 451); the Air Pollution Control Rules; and the conditions of Permit to Install (PTI) No. 283-04.

During the inspection, staff observed the following:

Wood furniture coating operation (EU-WOODPARTS)	PTI No. 283-04, Special Condition 1.2a	The VOC coating content for two sealers exceeded the 4.60 lb/gallon limit (minus water and exempt solvents).
Wood furniture coating operation (EU-WOODPARTS)	PTI No. 283-04, Special Condition 1.2b	The VOC coating content for four stains exceeded the 6.70 lb/gallon limit (minus water and exempt solvents).

Please initiate actions necessary to correct the cited violations and submit a written response to this Violation Notice by October 18, 2019 (which coincides with 21 calendar days from the date of this letter). The written response should include: the dates the violations occurred; an explanation of the causes and duration of the violations, whether the violations are ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violations and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence.
