AQD Staff traveled to N7467 Breitburn Hunt n Hayes Central Production Facility (CPF), located in Elmira Township, Otsego County, for a scheduled inspection to determine compliance with PTI 238-05. This is an opt out permit.

LOCATION

The facility is located in Hillman Township, Montmorency County. From Atlanta, travel east on M-32 2 ½ miles, turn north on Hall Road. Travel approximately 2 miles, the facility will be on the right side of the road.

REGULATORY DISCUSSION

PTI 238-05 was issued March 30, 2006 and is currently active. The permit was issued for one Caterpillar 399 TA, 830 hp compressor engine and a glycol dehydration system.

The engine is subject to 40 CFR Part 63, Subpart ZZZZ, which has not been delegated to MDEQ from EPA. The facility noted on the records that they are in compliance with Subpart ZZZZ regulations.

The dehy is subject to 40 CFR Part 63, Subpart HH, which also has not been delegated to MDEQ from EPA. The facility noted on their records that they are in compliance with Subpart HH regulations.

INSPECTION NOTES

Located on site is a large building containing a compressor engine and glycol dehydration system, and a lined bermed tank storage area with two tanks approximately 400 barrels each.

The engine was operating at 1205 RPM, engine oil pressure 50 PSI. There were no visible emissions or odor detected.

The stacks from the dehy and engine emit unobstructed vertically upward. Based on engineering judgement, the engine stack meets the requirements of the permit. The dehy does not have stack requirements in the permit.

COMPLIANCE DETERMINATION

Based on the site inspection, N7467 Breitburn Hunt n Hayes CPF is in compliance with the requirements of permit 238-05.
