VIOLATION NOTICE

On June 24, 2015, the Department of Environmental Quality (DEQ), Air Quality Division (AQD), conducted an inspection of Eagle Industries Inc. located at 30926 Century Drive, Wixom, Michigan. The purpose of this inspection was to determine Eagle Industries Inc. compliance with the requirements of the federal Clean Air Act; Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (Act 451); the administrative rules and the conditions of Renewable Operating Permit (ROP) number MI-ROP-N7578-2012b.

During the inspection, staff observed the following:

FGPOLYFOAM	MI-ROP-N7578-2012b FGPOLYFOAM Special Condition (S.C.) 1.5	As of March 2012, facility exceeded the hydrocarbon naphtha (CAS No. 64742-47-8) emission limit of 49,020 pounds per year

S.C. 1.5 of FGPOLYFOAM limits the emissions of hydrocarbon naphtha (CAS No. 64742-47-8) to 49,020 pounds per year, based on a 12-month rolling time period. The emission record provided for hydrocarbon naphtha shows exceedances of said emissions from March of 2012 through June of 2015.

Please initiate actions necessary to correct the cited violation and submit a written response to this Violation Notice by August 6, 2015 (which coincides with 21 calendar days from the date of this letter). The written response should include: the dates the violation occurred; an explanation of the causes and duration of the violation; whether the violation is ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violation and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence.

If Eagle Industries Inc. believes the above observations or statements are inaccurate or do not constitute violations of the applicable legal requirements cited, please provide appropriate factual information to explain your position.

Thank you for your attention to resolving the violation cited above and for the cooperation that was extended to me during my inspection of Eagle Industries, Inc.
