## **Inspection Summary**

I stopped to inspect this site on 10/7/16. The site is a vacant lot with partial concrete and gravel. Several sampling/monitoring well caps are dispersed throughout the property. No remediation device is on site.

Upon returning to the office, I contacted Marjorie regarding the site. Through a series of emails, I found that GES wanted to void the permit. I advised them that voidance of the permit would require additional permitting if further remediation is required unless the following conditions were met:

Should further remediation be needed, a new permit will need to be obtained unless the following conditions apply:

1. Two-stage carbon, thermal incineration or catalytic incineration control is utilized.

- 2. Stack heights are at least 1.5 times the building height.
  - 3. Actual emissions, after control, are less than two tons per year.
  - 4. The spill consisted of only VOCs from BTEX (Benzene, Toluene, Ethyl Benzene and Xylene), gasoline, fuel oils, or natural gas products (no chlorinated compounds or waste oil).

I also informed them that although the permit will be voided, this site will still have an "open" status in the RRD spill database until further action by the appropriate parties is completed. The RRD contact for this site is Marjorie Easton, 517-284-5108, eastonm1@michigan.gov
