**VIOLATION NOTICE**

On Tuesday, May 17, 2016, the Department of Environmental Quality (DEQ), Air Quality Division (AQD), conducted an inspection of SRW Forest Home 12 Facility located at SW 1/4, NE 1/4 Sec. 12 T30N R8W, Forest Home Township, Michigan. The purpose of this inspection was to determine SRW's compliance with the requirements of the federal Clean Air Act; Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (Act 451); the administrative rules and the conditions of Permit to Install (PTI) number 207-07.

During the inspection, staff observed the following:

Process Description	Rule/Permit Condition Violated	Comments
EUENGINE1 - natural gas fired reciprocating engine, discharging via stack identified as SVENGINE1	SC 1.12 – SVENGINE1 exhaust gases shall be discharged a minimum of 20 feet above ground level.	The height between the building foundation and the first bolt hold pattern was measured to be 4 feet. Based on an estimate using bolt hole patterns, the current height of the exhaust is approximately 15 feet above ground level.
EUENGINE1 - natural gas fired reciprocating engine, discharging via stack identified as SVENGINE1	SC 1.12 - SVENGINE1 exhaust gases shall be discharged unobstructed vertically upwards to the ambient air.	The exhaust pipe discharged to the side (directly west) instead of vertically upwards.

Please initiate actions necessary to correct the cited violations and submit a written response to this Violation Notice by June 20, 2016. The written response should include: the dates the violations occurred; an explanation of the causes and duration of the violations; whether the violations are ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violations and the dates by

which these actions will take place; and what steps are being taken to prevent a reoccurrence.

If SRW, Inc. believes the above observations or statements are inaccurate or do not constitute violations of the applicable legal requirements cited, please provide appropriate factual information to explain your position.

Thank you for your attention to resolving the violations cited above and for the cooperation that was extended to me during my inspection of the Forest Home 12 Facility.
