### PROCESS EQUIPMENT AND CONTROLS

The facility had been operating an unmanned air stripper, soil vapor extraction systems, and air sparging systems, and the associated air pollution control devices. This equipment would have been located onsite in a small trailer.

### **INSPECTION NARRATIVE**

I arrived at the facility. I drove around the perimeter of the facility. There was no evidence of any remediation equipment at the facility. It appears that the equipment has been removed.

A meeting involving Mr. Michael Cox as well as staff from the MDEQ-AQD from the Warren District Office has been set for Friday November 4, 2016 to discuss the multiple sites where the remediation equipment has been removed.

# APPLICABLE RULES/PERMIT CONDITIONS

The remediation equipment is operating under PTI 309-08, which was issued on September 29, 2008. There is one flexible group, which covered all of the remediation equipment.

On September 27, 2016 a letter was received from Speedway LLC requesting to void permit 309-08 because the equipment has been removed. An attached letter from Mr. Michael Cox with Practical Environmental Consultants, Inc. (PEC) stated that the remediation equipment had operated at this location between January 24, 2011 and June 30, 2011. This letter stated that the equipment had been removed from the site by July 5, 2011.

Based on the correspondence received from the facility as well as the visual inspection, it appears that the remediation equipment has been removed from this location. This general permit will be voided since it has been verified that this equipment has been removed.
