VIOLATION NOTICE

On October 16, 2017, the Department of Environmental Quality (DEQ), Air Quality Division (AQD), conducted a compliant investigation of Target Trucking, LLC (Company) located at 13650 Boyne Road near Grass Lake, Michigan. The purpose of this investigation was to determine the Company's compliance with the requirements of the federal Clean Air Act; Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (Act 451) and the associated Air Pollution Control Rules and to investigate dust complaints attributed to this facility.

During the compliant investigation, AQD staff observed the following:

Small portable non-metallic mineral rock crusher with no water spray bar control device.	Rule 201-No Permit to Install (PTI).	Crusher being operated on a non-production basis. However, it is not exempt from PTI requirements since the crusher was not equipped with water spray bar.
Three diesel engines. One powers a wash plant while the other 2 power portable dry screening operations.	40 CFR Part 63, Subpart ZZZZ - National Emissions Standards for Hazardous Air Pollutants for Stationary Reciprocating Internal Combustion Engines	The Company has not demonstrated that they are in compliance with this federal regulation. Two of three of the engines are portable but have not been moved offsite for more than 1 year so do not qualify for non-road engine exemption to federal requirements.

Please initiate actions necessary to correct the cited violations and submit a written response to this Violation Notice by November 14, 2017. The written response should include: the dates the violations occurred; an explanation of the causes and duration of the violations; whether the violations are ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violation and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence.

If the Company believes the above observations or statements are inaccurate or do not constitute violations of the applicable legal requirements cited, please provide appropriate factual information to explain your position.

Thank you for your attention to resolving the violations cited above and for the cooperation that was extended to me during my inspection of this Company.
