VIOLATION NOTICE

On June 7, 2017, the Department of Environmental Quality (DEQ), Air Quality Division (AQD), conducted an inspection of Gower Corporation located at 2840 Universal Drive, Saginaw, Michigan. The purpose of this inspection was to determine Gower Corporation's compliance with the requirements of the federal Clean Air Act; Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (Act 451); the Air Pollution Control Rules; and the conditions of Permit to Install (PTI) number 259-09

During the inspection, staff observed the following:

EUBURNOFF- Burn off used for electric motors	S.C. #1.9	No device installed to record the temperature in the afterburner once every 15 minutes.
EUBURNOFF- Burn off used for electric motors	S.C. #1.11	Missing 5 years of records for the afterburner temperature.
EUBURNOFF- Burn off used for electric motors	S.C. #1.12	Missing records of the date, duration, and description of any malfunction of the control equipment.

During this inspection, Gower Corporation was unable to produce emission records.

This is a violation of the recordkeeping and monitoring requirements specified in Special Condition number special conditions 1.9, 1.11, and 1.12 of PTI number 259-09.

record the temperature at least once every 15 minutes while in operation. A chart recorder is not installed on EUBURNOFF.

Please initiate actions necessary to correct the cited violations and submit a written response to this Violation Notice by June 29, 2017 (which coincides with 21 calendar days from the date of this letter). The written response should include: the dates the violations occurred; an explanation of the causes and duration of the violations; whether the violations are ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violations and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence.

If Gower Corporation believes the above observations or statements are inaccurate or do not constitute violations of the applicable legal requirements cited, please provide appropriate factual information to explain your position.

Thank you for your attention to resolving the violations cited above and for the cooperation that was extended to me during my inspection of Gower Corporation.
