**VIOLATION NOTICE**

On June 16, 2014, the Department of Environmental Quality (DEQ), Air Quality Division (AQD), conducted an inspection of Fisher Sand and Gravel Company located at 2400 Lakeshore Drive, Muskegon, Michigan. The purpose of this inspection was to determine Fisher Sand and Gravel Company's compliance with the requirements of the federal Clean Air Act; Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (Act 451); the administrative rules; and General Permit to Install No. 182-10.

During the inspection, staff observed the following:

Nonmetallic mineral crushing operation	Rule 336.1201	Failure to submit a relocation notice

During this inspection, it was noted that Fisher Sand and Gravel Company had relocated nonmetallic mineral crushing equipment without prior submittal of a relocation notice. The AQD staff advised Fisher Sand and Gravel Company on June 16 and 23, that this is a violation of Act 451, Rule 201.

Please initiate actions necessary to correct the cited violation and submit a written response to this Violation Notice by July 15, 2014 (which coincides with 21 calendar days from the date of this letter). The written response should include: the dates the violation occurred; an explanation of the causes and duration of the violation; whether the violation is ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violation and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence.
