On Friday, October 27, 2023, I, Noshin Khan, Michigan Department of Environment, Great Lakes, and Energy-Air Quality Division (EGLE-AQD) staff, performed a scheduled, on-site inspection of Dave's Bump and Spray Shop located at 1705 Minnie Street, Port Huron, Michigan 48060 (SRN: P0349). The purpose of the inspection was to determine the facility's compliance status with the requirements of the federal Clean Air Act; Article II, Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 Public Act 451, as amended (Act 451); and the AQD administrative rules.

I arrived at the location around 11:20AM. The facility at this location is now Doan Restoration of Michigan. I entered the facility and introduced myself to staff and explained the purpose of my visit. I asked if they knew if Dave's Bump and Spray Shop was previously located at the facility, and staff was unable to confirm. AQD records indicate that the last activity for Dave's Bump and Spray Shop was in 2012, and the reports indicate that the facility did repairs and spray painting for vehicles.

The General Manager for Doan Restoration of Michigan informed me that the business has been there since about 2017. They perform restoration services for issues including water damage, fires, and mold. The business stores its equipment at this location and takes what is needed to the restoration site using a trailer, which I observed parked in the driveway. Staff informed me that their equipment includes dehumidifiers, scrubbers, blowers, and a variety of cleaning agents. I observed these stored on racks in the facility. I did not observe any other processes or emission units on site, and staff informed me that there were none.

Based on my observations on-site, Doan Restoration of Michigan does not have any equipment or processes subject to any federal Clean Air Act; Article II, Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 Public Act 451, as amended (Act 451); and the AQD administrative rules.
