Franke Septic Tank Service LLC compliance inspection

I attempted to conduct an inspection of the minor source, Franke Septic Tank Service portable crusher on July 20, 2022, and again on July 27-2022 to determine compliance with Permit to Install 160-13 and the Michigan Air Pollution Control Rules. On 7-20-2022 I travelled to the site which is located on Franke Rd. just east of S. Mitchell St. in Cadillac, Mi. I followed the driveway back into the facility where the only vehicles were located at an office and shop on the north side of the property. No one was in the office, so I entered the shop and spoke to an employee there. He stated that that building was being leased from Franke Septic Tank Service by Salisbury Trucking and that they did not have anything to do with the crusher. They stated further that Franke Septic Tank personnel were out of town on a job until the following week. I left my business card with the employee.

There was a small pole building near the driveway on the south side of the property with the crusher plant located nearby. No one was at the building and the crusher plant did not appear to have been used recently, (see attached photos). I returned to the site on 7/27/20 and still no one was present, there had been no changes to the crusher plant. At that time, it appeared the plant was no longer in use.

On 8-16-2022, I received a call from Josh Salisbury of Salisbury Trucking. He stated that they were planning to buy Franke Septic Tank Service and operate the crusher. He wanted information on what they would need to do in order to begin using the crusher. I informed him about the permit for the plant and its major requirements, as well as offering to send him a copy of the permit and AQD website information regarding non-metallic mineral crushing. I recommended he thoroughly review the permit and make sure the crusher was meeting each of the requirements prior to beginning operation. I offered to meet him on-site to review the permit conditions with him. He agreed that would be beneficial once they purchased the company.
