VIOLATION NOTICE

On October 9, 2023, the Department of Environment, Great Lakes, and Energy (EGLE), Air Quality Division (AQD) conducted an inspection at E8890 M-28, Munising, Alger County. The purpose of this inspection was to determine compliance with the requirements of Title 40 of the Code of Federal Regulations (40 CFR), Part 61, Subpart M (National Emission Standard for Asbestos), and Rule 942 of Part 55, Air Pollution Control of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended.

According to my investigation, Grand Island Landing, Inc., owns the facility and Lakeshore Environmental, Inc., performed the abatement activities. The National Emission Standard for Asbestos (NESHAP) holds the *owner and operator* liable for all violations.

During the inspection, EGLE, AQD staff observed the following:

The facility was not demoed, and some abatement had occurred. However, additional duct insulation was noted throughout the facility on both the main floor and the basement along with broken and crumbled asbestos containing floor tile. The owner along with both the abatement and demolition contractor were notified regarding the additional materials. Demolition has been postponed.
