Mike told me that he remembers dismantling a pot-belly type burner that was installed behind the Vehicle Maintenance Facility (VMF) back in the 1990's. The VMF is a separate building and shares the same address as the Post Office. We walked back to the area and I confirmed the device was no longer installed. Both buildings are now heated via natural gas and I confirmed the VMF doesn't have a waste oil burner. We walked both buildings and I could not find other evidence of an incinerator in any other locations. I feel comfortable stating this device has been removed and the permit is no longer valid.
