They both escorted me to the mechanical section of the building which is located on the north-west side. We found the incinerator on the north end of the mechanical area. The incinerator is built into the wall of a room labeled MMB1101B which is right next to the elevator. This incinerator is still installed but was clearly not being operated; removal would take considerable reconstruction. The room was only about 3ft by 5 ft and was being used for storage. I feel comfortable stating this device is still installed but is non-operational thus been removed and the permit is no longer valid. The current phone number for this site is 810-232-8153.
