VIOLATION NOTICE

On September 2, 2020, the Department of Environment, Great Lakes, and Energy (EGLE), Air Quality Division performed an asbestos NESHAP (National Emission Standard for Hazardous Air Pollutants) inspection at 5811 South Westnedge Avenue and 5817 South Westnedge Avenue, Portage, Kalamazoo County. The purpose of this inspection was to determine compliance with the requirements of Title 40 of the Code of Federal Regulations (40 CFR), Part 61, Subpart M (National Emission Standard for Asbestos), and Rule 942 of Part 55, Air Pollution Control of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended.

According to my investigation, Seerco, Inc. represents the owner of the subject property and Balkema Sitework and Development, LLC, performed the demolition activities. The National Emission Standard for Asbestos holds both the *owner and operator* equally liable for any violations.

During the inspection, staff observed the following:

The subject facilities had been demolished by Balkema Sitework and Development, LLC. During the inspection, site-work was being performed by Balkema Sitework and Development, LLC. During the inspection it was noted that the subject facility had an abatement notification into the Michigan Occupational Safety and Health Administration for asbestos abatement at a previous date. However, a 10-day notification of intent to demolish had not been submitted by the demolition contractor.

Please initiate actions necessary to correct the cited violation and submit a written response to this violation notice by October 2, 2020, (which coincides with 21 calendar days from the date of this letter). The written response should include: the date the violation occurred; an explanation of the causes and duration of the violation; whether the violation is ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violation, and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence.
