VIOLATION NOTICE

On March 20, 2017, the Michigan Department of Environmental Quality (MDEQ), Air Quality Division, performed an asbestos NESHAP (National Emission Standard for Hazardous Air Pollutants) inspection at 416 Jerome Street, Midland, Midland County. The purpose of this inspection was to determine compliance with the requirements of Title 40 of the Code of Federal Regulations, Part 61, Subpart M (National Emission Standard for Asbestos), and Rule 942 of Part 55, Air Pollution Control of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (Act 451).

According to my investigation, Michigan Baseball Foundation owns the subject facility and Pat's Gradall Service, Inc., performed the demolition. The demolition activities took place on or about March 20, 2017. The National Emission Standard for Asbestos holds both the owner and operator equally liable for any violations.

During the inspection, staff noted the following: the residential structure had been demolished, and both the Michigan Baseball Foundation and Pat's Gradall Service, Inc., failed to submit a 10-working day notification of Intent to Renovate/Demolish to the administrator prior to the demolition activities. Additionally, the Michigan Baseball Foundation and Pat's Gradall Service, Inc., failed to submit a 10-working day notification of Intent to Renovate/Demolish prior to the demolition activities that took place at 402 Jerome, 406 Jerome and 410 Jerome Street, Midland, Midland County, as well.
