On August 19, 2014, I conducted a level-2 self-initiated inspection of Sun Pharmaceutical Industries, Inc. ("the company" or "Sun Pharma") located at 31060 Oak Creek Dr., Wixom, Michigan 48393-2441. The inspection was conducted to determine compliance with the Federal Clean Air Act; Article II, Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 PA 451 and Michigan Department of Environmental Quality, Air Quality Division (MDEQ-AQD) rules.

During the inspection, Mr. Robert Leahey (Phone: 313-871-8400-ext. 4315; Cell: 313-401-7343; Fax: 313-556-4131; E-mail: <u>Robert.eahey@caraco.com</u>), Associate Director of Distribution, and Mr. Ehmad Walker (Phone: 313-556-4186), Distribution Manager, assisted me.

The Sun Pharma imports pharmaceutical products from India; no more from China. Sun Pharma warehouses the imported generic pharmaceutical products, packages in bigger boxes and distributes them. Sun Pharma only distributes pharmaceutical products and there is no manufacturing taking place. In a couple of months (by November 2014), generic drug manufacturing in Detroit will cease. Sun Pharma is an Indian company and therefore almost all drugs are imported from India.

Rule 287(c) paint spray booth

The booth is equipped with back-draft dry filters. The booth is not used for painting. It is used as a storage space. It continues to be idled.

Conclusion:

Only regulated process equipment at this site is paint spray booth (Rule 336.1287) that is now indefinitely idled.
