

## VIOLATION NOTICE

On May 23, 2019, the Michigan Department of Environment, Great Lakes and Energy, Air Quality Division (AQD), conducted a compliant investigation of Boullion Sales Inc. (Company) located at 8530 N. Territorial Road, Dexter, Michigan. The purpose of this inspection was to determine the Company's compliance with the requirements of the federal Clean Air Act; Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (Act 451) and the associated Air Pollution Control Rules.

During the compliant investigation, AQD staff observed the following:

Open burn pit that has been used for decades to burn/dispose of trash generated from this facility.	Rule 310.	Burning of trash at a commercial business is prohibited.

Please initiate actions necessary to correct the cited violation and submit a written response to this Violation Notice by June 19, 2019. The written response should include: the dates the violation occurred; an explanation of the causes and duration of the violation; whether the violation is ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violation and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence.
