VIOLATION NOTICE

On May 31, 2016, the Department of Environmental Quality (DEQ), Air Quality Division, conducted an inspection of the residential properties located at 26811 and 26851 Ford Road, Dearborn Heights. The purpose of this inspection was to determine Heights Investment Group, LLC's and BHI Contracting, Inc.'s compliance with the requirements of Title 40 of the Code of Federal Regulations, Part 61, Subpart M (National Emission Standard for Asbestos), and Rule 942 of Part 55, Air Pollution Control of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended.

According to our investigation, Heights Investment Group, LLC owns the property and BHI Contracting, Inc. performed the demolition activities at the facility. The National Emission Standard for Asbestos holds both the owner and operator equally liable for violations.

During the inspection, staff observed that the residential properties were demolished without the submittal of the required 10 day notification of intent to demolish to AQD.

If Heights Investment Group, LLC and/or BHI Contracting, Inc. believes the above observations or statements are inaccurate or do not constitute violations of the applicable legal requirements cited, please provide appropriate factual information to explain your position.
