

## **VIOLATION NOTICE**

On June 21, 2017, the Michigan Department of Environmental Quality (MDEQ), Air Quality Division (AQD), performed an asbestos inspection at 19187 Lamont Street, Detroit, Wayne County, Michigan. The purpose of this inspection was to determine compliance with the requirements of Title 40 of the Code of Federal Regulations, Part 61, Subpart M (National Emission Standard for Asbestos), and Rule 942 of Part 55, Air Pollution Control of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (Act 451).

According to our investigation, the Detroit Land Bank owns the property and was under a contract for demolition through the City of Detroit and the Detroit Building Authority, which oversees demolitions for the City. Salenbien Trucking and Excavating, Inc. notified and conducted demolition at the site. The National Emission Standard for Asbestos holds the <u>owner</u> and <u>operators</u> equally liable for all violations.

During the investigation, DEQ AQD staff, Mr. Jeremiah Brown and Ms. Tammy Bell observed/discovered the following:

The subject property had undergone a partial asbestos abatement. Due to safety concerns, the entire structure was not abated. Asbestos was left in/on the structure, and was demolished as a partial ordered demolition (all debris must be treated as Friable RACM). During our inspection of the property, Regulated Asbestos-Containing Material (RACM) was located in several different locations that had not been removed.

Please initiate actions necessary to correct the cited violation and submit a written response to this violation notice by July 18, 2017, (which coincides with 21 calendar days from the date of this letter). The written response should include: the date(s) the violation occurred; an explanation of the causes and duration of the violation; whether the violation is ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violation, and the date(s) by which these actions will take place; and what steps are being taken to prevent a reoccurrence. The <u>signed</u> written response from both the <u>owners and operators</u> to this violation notice may be submitted by mail and directed to my attention at; DEQ AQD, P.O. Box 30260, Lansing, Michigan 48909, or scanned and sent as an email attachment to brownj9@michigan.gov.

If you believe the above observations or statements are inaccurate or do not constitute a violation of the applicable legal requirements cited, please provide appropriate factual information to explain your position.
