## **VIOLATION NOTICE**

On November 26, 2018, the Department of Environmental Quality (DEQ), Air Quality Division (AQD), conducted an inspection of the residential property located at 14444 Flanders, Detroit. The purpose of the inspection was to determine compliance with the requirements of Title 40 of the Code of Federal Regulations (CFR), Part 61, National Emission Standards for Hazardous Air Pollutants (NESHAP), Subpart M and Rule 942 of the administrative rules promulgated under Part 55, Air Pollution Control of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended.

According to our investigation, the Detroit Building Authority manages the City of Detroit's demolition program, the Detroit Land Bank Authority owns the property, and Den-Man Contractors, Inc. performed demolition activities at the site. The NESHAP for Asbestos holds the owner and operators liable for violations.

On November 15, 2018, the Detroit Building Authority advised the AQD that the residential property had been demolished without the removal of regulated asbestos containing materials (RACM).

According to the asbestos survey, the building contained an estimated 110 linear feet of caulk, 50 square feet of duct insulation, and 800 square feet of plaster. An additional 7,100 square feet of plaster was noted in the asbestos survey as containing trace amounts of asbestos. The additional plaster did not appear to have been analyzed by the point count method and is presumed as RACM.

Please initiate actions necessary to correct the cited violations and submit a signed written response to this Violation Notice by December 28, 2018 (which coincides with 21 calendar days from the date of this letter). The response should include: the dates the violations occurred; an explanation of the causes and duration of the violations; whether the violations are ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violations, and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence.

If Den-Man Contractors, Inc., the Detroit Land Bank Authority, and/or the Detroit Building Authority believes the above observations or statements are inaccurate or do not constitute violations of the applicable legal requirements cited, please provide factual information to explain your position.
