

NOTICE of AIR POLLUTION COMMENT PERIOD

The Michigan Department of Environmental Quality (DEQ) is holding a public comment period from June 18, 2009, until August 17, 2009, on Wolverine Power Supply Cooperative, Inc.'s. submittal of an analysis of alternatives to the proposed coal-fired power plant. The facility is proposed to be located at the Oglebay-Norton Quarry property, Rogers Township, Presque Isle County, Michigan. The public comment period is to allow all interested parties the opportunity to review and comment on the analysis of alternatives as submitted by Wolverine Power Supply Cooperative, Inc.

In response to comments received during the initial comment period for this proposal and consistent with state and federal law, specifically Rule 1817(2) of the Michigan Air Pollution Control Rules and Section 165(a)(2) of the federal Clean Air Act, the DEQ requested that Wolverine Power Supply Cooperative, Inc. conduct an analysis of alternatives to the proposed coal-fired power plant. The DEQ entered into a Memorandum of Understanding (<http://www.deq.state.mi.us/aps/downloads/permits/PubNotice/341-07/MOU-DEQandPSC.pdf>) with the Michigan Public Service Commission (PSC) to identify each agency's role and responsibility regarding the analysis of alternatives and technical assistance. Upon completion of its review, the PSC will provide the DEQ with its conclusions as to the matters related to electric generation need in the state. These conclusions will be integrated into the DEQ file and used in the decision-making process. The PSC will provide an opportunity to comment on the submitted analysis of alternatives via separate notice.
