GENERAL CONDITIONS

- 1. The process or process equipment covered by this permit shall not be reconstructed, relocated, or modified, unless a Permit to Install authorizing such action is issued by the Department, except to the extent such action is exempt from the Permit to Install requirements by any applicable rule. [R336.1201(1)]
- 2. If the installation, construction, reconstruction, relocation, or modification of the equipment for which this permit has been approved has not commenced within 18 months, or has been interrupted for 18 months, this permit shall become void unless otherwise authorized by the Department. Furthermore, the permittee or the designated authorized agent shall notify the Department via the Supervisor, Permit Section, Air Quality Division, Michigan Department of Environmental Quality, P.O. Box 30260, Lansing, Michigan 48909, if it is decided not to pursue the installation, construction, reconstruction, relocation, or modification of the equipment allowed by this Permit to Install. [R336.1201(4)]
- 3. If this Permit to Install is issued for a process or process equipment located at a stationary source that is not subject to the Renewable Operating Permit program requirements pursuant to R336.1210, operation of the process or process equipment is allowed by this permit if the equipment performs in accordance with the terms and conditions of this Permit to Install. [R336.1201(6)(b)]
- 4. The Department may, after notice and opportunity for a hearing, revoke this Permit to Install if evidence indicates the process or process equipment is not performing in accordance with the terms and conditions of this permit or is violating the Department's rules or the Clean Air Act. [R336.1201(8), Section 5510 of Act 451, PA 1994]
- 5. The AQD District Supervisor shall be notified, in writing, of a change in ownership or operational control of the stationary source or emission unit(s) authorized by this Permit to Install pursuant to R336.1219. The notification shall include all of the information required by R336.1219(1)(a) and (b). In addition, a new owner or operator must submit a written statement pursuant to R336.1219(1)(c), agreeing to and accepting the terms and conditions of this Permit to Install, and shall notify the AQD District Supervisor of any change in the contact person for this Pemit to Install. [R336.1219]
- 6. Operation of this equipment shall not result in the emission of an air contaminant which causes injurious effects to human health or safety, animal life, plant life of significant economic value, or property, or which causes unreasonable interference with the comfortable enjoyment of life and property. [R336.1901]
- 7. The permittee shall provide notice of an abnormal condition, start-up, shutdown, or malfunction that results in emissions of a hazardous or toxic air pollutant which continue for more than one hour in excess of any applicable standard or limitation, or emissions of any air contaminant continuing for more than two hours in excess of an applicable standard or limitation, as required in Rule 912, to the Department. The notice shall be provided not later than two business days after start-up, shutdown, or discovery of the abnormal condition or malfunction. Written reports, if required, must be filed with the Department within 10 days after the start-up or shutdown occurred, within 10 days after the abnormal condition or malfunction has been corrected, or within 30 days of discovery of the abnormal condition or malfunction, whichever is first. The written reports shall include all of the information required in Rule 912(5). [R336.1912]
- 8. Approval of this permit does not exempt the permittee from complying with any future applicable requirements which may be promulgated under Part 55 of 1994 PA 451, as amended or the Federal Clean Air Act.

- 9. Approval of this permit does not obviate the necessity of obtaining such permits or approvals from other units of government as required by law.
- 10. Operation of this equipment may be subject to other requirements of Part 55 of 1994 PA 451, as amended and the rules promulgated thereunder.
- 11. Except as provided in subrules (2) and (3) or unless the special conditions of the Permit to Install include an alternate opacity limit established pursuant to subrule (4) of R336.1301, the permittee shall not cause or permit to be discharged into the outer air from a process or process equipment a visible emission of density greater than the most stringent of the following. The grading of visible emissions shall be determined in accordance with R336.1303. [R336.1301]
 - a) A six-minute average of 20 percent opacity, except for one six-minute average per hour of not more than 27 percent opacity.
 - b) A visible emission limit specified by an applicable federal new source performance standard.
 - c) A visible emission limit specified as a condition of this permit to install.
- 12. Collected air contaminants shall be removed as necessary to maintain the equipment at the required operating efficiency. The collection and disposal of air contaminants shall be performed in a manner so as to minimize the introduction of contaminants to the outer air. Transport of collected air contaminants in Priority I and II areas requires the use of material handling methods specified in R336.1370(2). [R336.1370]
- 13. The Department may require the permittee to conduct acceptable performance tests, at the permittee's expense, in accordance with R336.2001 and R336.2003, under any of the conditions listed in R336.2001. [R336.2001]

Equipment

1.1 The permittee shall not operate EU-HY22DEHY unless the flash tank is installed, maintained, and operated in a satisfactory manner. Satisfactory operation includes recycling/recompressing the flash tank exhaust gas. [R336.1205(3), R336.1702(a), R336.1910]

Testing

1.2 At least once each calendar year the permittee shall obtain, by sampling, an analysis of the wet gas stream. The sample shall be analyzed for nitrogen, carbon dioxide, hydrogen sulfide, C1 through C6 series hydrocarbons, benzene, toluene, xylene, ethylbenzene, and heptanes plus. Any request for a change in the sampling frequency must be submitted to the AQD District Supervisor for review and approval. [R336.1205(3), R336.1702(a)]

Monitoring

1.3 The permittee shall monitor, in a satisfactory manner, the natural gas processing rate and glycol recirculation rate of EU-HY22DEHY on a monthly basis. [R336.1205(3), R336.1702(a)]

Recordkeeping/Reporting/Notification

1.4 All required calculations shall be completed in a format acceptable to the AQD District Supervisor and made available by the 15th day of the calendar month, for the previous calendar month, unless otherwise specified in any recordkeeping, reporting or notification special condition. [R336.1205(3), R336.1702(a)]

1.5 The permittee shall keep, in a satisfactory manner, the following records for EU-HY22DEHY. All records shall be kept on file at a location approved by the District Supervisor for a period of at least five years and made available to the Department upon request.

Process/Operational Limits

- 2.1 No later than 60 days after issuance of this permit, the permittee shall submit to the AQD District Supervisor, for review and approval, a malfunction abatement/preventative maintenance plan for EUENGINE1. After approval of the malfunction abatement/preventative maintenance plan by the AQD District Supervisor, the permittee shall not operate EUENGINE1 unless the malfunction abatement/preventative maintenance plan, or an alternate plan approved by the AQD District Supervisor, is implemented and maintained. The plan shall incorporate procedures recommended by the equipment manufacturer as well as incorporating standard industry practices. At a minimum the plan shall include:
 - a. Identification of the equipment and control equipment and the personnel responsible for overseeing the inspection, maintenance, and repair
 - b. Description of the items or conditions to be inspected and frequency of the inspections or repairs
 - c. Description of equipment and add-on air pollution control device operating parameters that shall be monitored to detect a malfunction or failure, the normal operating range of the equipment and a description of the method of monitoring or surveillance procedures
 - d. Listing of all spare parts that will be kept on site for the equipment covered in the plan
 - e. Procedures for maintaining and operating in a satisfactory manner EUENGINE1, add-on air pollution control device, or monitoring equipment during malfunction events, and a program for corrective action for such events

If the malfunction abatement plan fails to address or inadequately addresses an event that meets the characteristics of a malfunction at the time the plan is initially developed, the owner or operator shall revise the malfunction abatement plan within 45 days after such an event occurs and submit the revised plan for approval to the AQD District Supervisor. Should the AQD determine the malfunction abatement/preventative maintenance plan to be inadequate, the District Supervisor may request modification of the plan to address those inadequacies. [R336.1205(3), R336.1225, R336.1702(a), R336.1911]

2.2 The permittee shall not operate EUENGINE1 without catalytic converter for more than 200 hours per engine per year consistent with the malfunction abatement/preventative maintenance plan (pursuant to SC 2.1). The 200 hours shall include times after an engine change-out occurs (pursuant to SC 2.7) and general maintenance performed as allowed by the malfunction abatement/preventative maintenance plan. The hours per year limit is based on a 12-month rolling time period as determined at the end of each calendar month. [R336.1205(3), R336.1225, R336.1702(a)]

Equipment

2.3 The permittee shall not operate EUENGINE1 unless the catalytic converter system is installed, maintained, and operated in a satisfactory manner, except as specified in SC 2.2. Satisfactory operation includes performing the manufacturer's recommended maintenance on the catalytic converter system. If the permittee changes-out one or more of these engines with engine(s) that achieve equivalent emission rates, or lower emission rates, without add-on control equipment (pursuant to SC 2.7), this condition does not apply for that engine or engines. [R336.1205(3), R336.1225, R336.1702(a), R336.1910]

Testing

2.4 The permittee shall verify NOx emission rates from EUENGINE1, by testing at owner's expense, in accordance with Department requirements, upon request by the AQD District Supervisor. No less than 60 days prior to testing, the permittee shall submit a complete test plan to the AQD. The AQD must approve the final plan prior to testing. Verification of emission rates includes the submittal of a complete report of the test results to the AQD within 60 days following the last date of the test. [R336.1205(3), R336.2001, R336.2003, R336.2004]

Monitoring

- 2.5 The permittee shall install, calibrate, maintain and operate in a satisfactory manner a device to monitor and record the natural gas usage from EUENGINE1 on a continuous basis. [R336.1205(3)]
- 2.6 The permittee shall monitor, in a satisfactory manner, the natural gas usage from EUENGINE1 on a monthly basis. [R336.1205(3)]

Recordkeeping/Reporting/Notification

- 2.7 The permittee shall complete all required calculations in a format acceptable to the AQD District Supervisor and make them available by the 15th day of the calendar month, for the previous calendar month, unless otherwise specified in any recordkeeping, reporting or notification special condition. [R336.1205(3), R336.1225, R336.1702(a), R336.1901]
- 2.8 The permittee shall maintain a log of all significant maintenance activities conducted and all repairs made to EUENGINE1 and any associated air pollution control device(s). The permittee shall keep this log on file at the facility for a period of at least five years and make it available to the Department upon request. If EUENGINE1 is replaced with an equivalent emitting, or less emitting engine, the permittee shall notify the AQD District Supervisor of such change-out and submit acceptable emissions data to show that the alternate engine is equivalent emitting or less emitting. [R336.1205(3), R336.1225, R336.1702(a), R336.1911]
- 2.9 The permittee shall keep, in a satisfactory manner, monthly and 12-month rolling time period hours that EUENGINE1 operated without the catalytic converter system. The permittee shall keep all records on file at the facility for a period of at least five years and make them available to the Department upon request. [R336.1205(3), R336.1225, R336.1702(a)]

2.10 The permittee shall keep, in a satisfactory manner, monthly fuel use records for EUENGINE1, as required by SC 2.5. The permittee shall keep all records on file at the facility for a period of at least five years and make them available to the Department upon request. [R336.1205(3)]

3.1 The permittee shall not operate FGTANKS unless the vapor recovery unit (VRU) control is installed, maintained, and operated in a satisfactory manner on the 400-barrel oil storage tanks. [R336.1205(3), R336.1702(a)]

Material Limits

4.2 The permittee shall only burn sweet natural gas in FGFACILITY. [R336.1205(3)]

Testing

4.3 Verification of H2S and/or sulfur content of the natural gas burned in FGFACILITY may be required upon request by the AQD District Supervisor. This condition is necessary to ensure compliance with SC 4.2. [R336.1205(3)]

Recordkeeping / Reporting / Notification

4.4 The permittee shall complete all required calculations in a format acceptable to the AQD District Supervisor and make them available by the 15th day of the calendar month, for the previous calendar month, unless otherwise specified in any recordkeeping, reporting or notification special condition. [R336.1205(3)]

4.5 The permittee shall keep, in a satisfactory manner, monthly and 12-month rolling time period NOx emission calculation records for FGFACILITY, as required by SC 4.1a and Appendix A. The permittee shall keep all records on file at the facility for a period of at least five years and make them available to the Department upon request. [R336.1205(3)]

APPENDIX A Procedures for Calculating Facility NOx Emissions

The permittee shall demonstrate compliance with the NOx emission limits by keeping track of all fuel usage for all equipment using such fuel at this facility and multiplying that fuel usage by an equipment specific emission factor. The emission factors are typically expressed as a mass weight of pollutant per unit of fuel.

The permittee shall only use emission factors from equipment vendor guarantees or from source specific testing (stack testing) for EUENGINE1. For all other fuel burning equipment the permittee shall use emission factors contained in the most recent AP-42 (Compilation of Air Pollutant Emission Factors) or the most recent FIRE (Factor Information Retrieval) database if vendor or stack data is not available. If other emission source values are used, the permittee shall obtain the approval of the district supervisor before using the emission factors to calculate emissions.

The permittee shall document the source and date of origin of the emission factors used in the calculations.
