GENERAL CONDITIONS

- 1. The process or process equipment covered by this permit shall not be reconstructed, relocated, or modified, unless a Permit to Install authorizing such action is issued by the Department, except to the extent such action is exempt from the Permit to Install requirements by any applicable rule. [R336.1201(1)]
- 2. If the installation, construction, reconstruction, relocation, or modification of the equipment for which this permit has been approved has not commenced within 18 months, or has been interrupted for 18 months, this permit shall become void unless otherwise authorized by the Department. Furthermore, the permittee or the designated authorized agent shall notify the Department via the Supervisor, Permit Section, Air Quality Division, Michigan Department of Environmental Quality, P.O. Box 30260, Lansing, Michigan 48909, if it is decided not to pursue the installation, construction, reconstruction, relocation, or modification of the equipment allowed by this Permit to Install. [R336.1201(4)]
- 3. If this Permit to Install is issued for a process or process equipment located at a stationary source that is not subject to the Renewable Operating Permit program requirements pursuant to R336.1210, operation of the process or process equipment is allowed by this permit if the equipment performs in accordance with the terms and conditions of this Permit to Install. [R336.1201(6)(b)]
- 4. The Department may, after notice and opportunity for a hearing, revoke this Permit to Install if evidence indicates the process or process equipment is not performing in accordance with the terms and conditions of this permit or is violating the Department's rules or the Clean Air Act. [R336.1201(8), Section 5510 of Act 451, PA 1994]
- 5. The AQD District Supervisor shall be notified, in writing, of a change in ownership or operational control of the stationary source or emission unit(s) authorized by this Permit to Install pursuant to R336.1219. The notification shall include all of the information required by R336.1219(1)(a) and (b). In addition, a new owner or operator must submit a written statement pursuant to R336.1219(1)(c), agreeing to and accepting the terms and conditions of this Permit to Install, and shall notify the AQD District Supervisor of any change in the contact person for this Pemit to Install. [R336.1219]
- 6. Operation of this equipment shall not result in the emission of an air contaminant which causes injurious effects to human health or safety, animal life, plant life of significant economic value, or property, or which causes unreasonable interference with the comfortable enjoyment of life and property. [R336.1901]
- 7. The permittee shall provide notice of an abnormal condition, start-up, shutdown, or malfunction that results in emissions of a hazardous or toxic air pollutant which continue for more than one hour in excess of any applicable standard or limitation, or emissions of any air contaminant continuing for more than two hours in excess of an applicable standard or limitation, as required in Rule 912, to the Department. The notice shall be provided not later than two business days after start-up, shutdown, or discovery of the abnormal condition or malfunction. Written reports, if required, must be filed with the Department within 10 days after the start-up or shutdown occurred, within 10 days after the abnormal conditions or malfunction has been corrected, or within 30 days of discovery of the abnormal condition or malfunction, whichever is first. The written reports shall include all of the information required in Rule 912(5). [R336.1912]
- 8. Approval of this permit does not exempt the permittee from complying with any future applicable requirements which may be promulgated under Part 55 of 1994 PA 451, as amended or the Federal Clean Air Act.

- 9. Approval of this permit does not obviate the necessity of obtaining such permits or approvals from other units of government as required by law.
- 10. Operation of this equipment may be subject to other requirements of Part 55 of 1994 PA 451, as amended and the rules promulgated thereunder.
- 11. Except as provided in subrules (2) and (3) or unless the special conditions of the Permit to Install include an alternate opacity limit established pursuant to subrule (4) of R336.1301, the permittee shall not cause or permit to be discharged into the outer air from a process or process equipment a visible emission of density greater than the most stringent of the following. The grading of visible emissions shall be determined in accordance with R336.1303. [R336.1301]
 - a) A six-minute average of 20 percent opacity, except for one six-minute average per hour of not more than 27 percent opacity.
 - b) A visible emission limit specified by an applicable federal new source performance standard.
 - c) A visible emission limit specified as a condition of this permit to install.
- 12. Collected air contaminants shall be removed as necessary to maintain the equipment at the required operating efficiency. The collection and disposal of air contaminants shall be performed in a manner so as to minimize the introduction of contaminants to the outer air. Transport of collected air contaminants in Priority I and II areas requires the use of material handling methods specified in R336.1370(2). [R336.1370]
- 13. The Department may require the permittee to conduct acceptable performance tests, at the permittee's expense, in accordance with R336.2001 and R336.2003, under any of the conditions listed in R336.2001. [R336.2001]

The following conditions apply to: EUENGINE

Process/Operational Limits

- 1.1 No later than 60 days after issuance of this permit, the permittee shall submit to the AQD District Supervisor, for review and approval, a malfunction abatement/preventative maintenance plan for EUENGINE. After approval of the malfunction abatement/preventative maintenance plan by the AQD District Supervisor, the permittee shall not operate EUENGINE unless the malfunction abatement/preventative maintenance plan, or an alternate plan approved by the AQD District Supervisor, is implemented and maintained. The plan shall incorporate procedures recommended by the equipment manufacturer as well as incorporating standard industry practices. At a minimum Rule 911 requires the plan to include:
 - a. Identification of the equipment and control equipment and the supervisory personnel responsible for overseeing the inspection, maintenance, and repair.
 - b. Description of the items or conditions to be inspected and frequency of the inspections or repairs.
 - c. Description of equipment and add-on air pollution control device operating parameters that shall be monitored to detect a malfunction or failure, the normal operating range of the equipment and a description of the method of monitoring or surveillance procedures.
 - d. Identification of the major replacement parts that shall be maintained in inventory for quick replacement.
 - e. A description of the corrective procedures or operational changes that shall be taken in the event of a malfunction or failure to achieve compliance with the applicable emission limits.

If the malfunction abatement plan fails to address or inadequately addresses an event that meets the characteristics of a malfunction at the time the plan is initially developed, the owner or operator shall revise the malfunction abatement plan within 45 days after such an event occurs and submit the revised plan for approval to the AQD District Supervisor. Should the AQD determine the malfunction abatement/preventative maintenance plan to be inadequate, the District Supervisor may request modification of the plan to address those inadequacies. [R336.1205(3), R336.1225, R336.1910, R336.1911]

1.2 The permittee shall not operate EUENGINE without the add-on control device for more than 200 hours per year consistent with the malfunction abatement/preventative maintenance plan (pursuant to SC 1.1). The 200 hours shall include times after an engine change-out occurs (pursuant to SC 1.7) and general maintenance performed as allowed by the malfunction abatement/preventative maintenance plan. The hours per year limit is based on a 12-month rolling time period as determined at the end of each calendar month. If the permittee changes-out the engine with an engine that achieves equivalent emission rates, or lower emission rates, without add-on control equipment (pursuant to SC 1.7), this condition does not apply to that engine. [R336.1205(3), R336.1225, R336.1702(a)]

Equipment

1.3 The permittee shall not operate EUENGINE unless the add-on control device is installed, maintained, and operated in a satisfactory manner, except as specified in SC 1.2. Satisfactory operation includes performing the manufacturer's recommended maintenance on the add-on control device and operating in conjunction with the malfunction abatement/preventative maintenance plan specified in SC 1.1. If the permittee changes-out the engine with an engine that achieves equivalent emission rates, or lower emission rates, without add-on control equipment (pursuant to SC 1.7), this condition does not apply for that engine. [R336.1205(3), R336.1225, R336.1702(a), R336.1910]

Testing

1.4 Verification of NOx emission rates from EUENGINE, by testing at owner's expense, in accordance with Department requirements, may be required upon request by the AQD District Supervisor. No less than 60 days prior to testing, a complete test plan shall be submitted to the AQD. The final plan must be approved by the AQD prior to testing. Verification of emission rates includes the submittal of a complete report of the test results to the AQD within 60 days following the last date of the test. [R336.1205(3), R336.2001, R336.2003, R336.2004]

Monitoring

1.5 No later than 180 days after issuance of this permit, the permittee shall monitor, in a satisfactory manner, the natural gas usage for EUENGINE on a continuous basis. [R336.1205(3)]

Recordkeeping/Reporting/Notification

- 1.6 All required calculations shall be completed in a format acceptable to the AQD District Supervisor and made available by the last day of the calendar month, for the previous calendar month, unless otherwise specified in any recordkeeping, reporting or notification special condition. [R336.1205(3), R336.1225, R336.1702(a)]
- 1.7 The permittee shall maintain a log of all significant maintenance activities conducted and all repairs made to EUENGINE and any associated air pollution control device(s). This log shall be kept on file at a location approved by the District Supervisor for a period of at least five years and made available to the Department upon request. If EUENGINE is replaced with an equivalent emitting, or less emitting engine, the permittee shall notify the AQD District Supervisor of such change-out and submit acceptable emissions data to show that the alternate engine is equivalent emitting or less emitting. [R336.1205(3), R336.1225, R336.1702(a), R336.1911]
- 1.8 The permittee shall keep, in a satisfactory manner, records of the monthly and previous 12-month hours during which EUENGINE operated without the add-on control device. All records shall be kept on file at a location approved by the District Supervisor for a period of at least five years and made available to the

Department upon request. If the permittee performs an engine change-out and a control device is not used, this condition does not apply to that engine. [R336.1205(3), R336.1225, R336.1702(a)]

1.9 The permittee shall keep, in a satisfactory manner, monthly fuel use records for EUENGINE, as required by SC 1.5. All records shall be kept on file at a location approved by the District Supervisor for a period of at least five years and made available to the Department upon request. [R336.1205(3)]

Material Limits

2.2 The permittee shall only burn sweet natural gas in FGFACILITY. [R336.1205(3)]

Testing

2.3 Verification of H2S and/or sulfur content of the natural gas burned in FGFACILITY may be required upon request by the AQD District Supervisor. This condition is necessary to ensure compliance with SC 2.2. [R336.1205(1)(a) and (3)]

Recordkeeping / Reporting / Notification

- All required calculations shall be completed in a format acceptable to the AQD District Supervisor and made available by the last day of the calendar month, for the previous calendar month, unless otherwise specified in any recordkeeping, reporting or notification special condition. [R336.1205(3)]
- 2.5 The permittee shall keep, in a satisfactory manner, monthly and 12-month rolling time period NOx emission calculation records for FGFACILITY, as required by SC 2.1a and Appendix A. All records shall be kept on file at a location approved by the District Supervisor for a period of at least five years and made available to the Department upon request. [R336.1205(3)]

APPENDIX A Procedures for Calculating Facility NOx Emissions

The permittee shall demonstrate compliance with the NOx emission limit by keeping track of all fuel usage for all equipment using such fuel at this facility and multiplying that fuel usage by an equipment-specific emission factor. The emission factors are typically expressed as a mass weight of pollutant per unit of fuel.

The permittee shall only use a NOx emission factor from either equipment vendor guarantees or from source specific testing (stack testing) for EUENGINE. For all other fuel burning equipment the permittee shall use NOx emission factors contained in the most recent AP-42 (Compilation of Air Pollutant Emission Factors) or the most recent FIRE (Factor Information Retrieval Emission) database if vendor or stack data is not available. If another emission source value is used, the permittee shall obtain the approval of the District Supervisor before using an alternative emission factor to calculate emissions.

The permittee shall document the source and date of origin of the emission factors used in the calculations.
