Background

SAF Holland SRN:A5936 is an automotive component manufacturing facility. The production facility is located at 430 W 18th Street, Holland Michigan. The facility was inspected on 12/20/2017 by Tyler Salamasick, Environmental Quality Analyst of the Michigan Department of Environmental Quality, Air Quality Division. The intent of the inspection was to determine the facility's compliance with the Federal Clean Air Act Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act of 1994, PA 451, as amended, Michigan's Air Pollution Control Rules and PTI No. 194-14. SAF Holland was formerly a 208A source, but obtained a true opt-out permit in 2014. The facility was opt-out for carbon monoxide (CO).

Inspection

Site arrival was at 10:00 am on 12/20/2017. Upon arrival I met with the Plant Manager, Joe Reynolds. Joe informed me that the plant shut down and would no longer operate. The facility had removed or disconnected all equipment that was a significant source of air contaminants. Joe informed me that the salt quench (PTI 194-14) has been removed and shipped to Warrenton Missouri. We walked through the facility and I observed the salt quench had been removed. I also observed the quench oil process and observed that it had been disabled. The vast majority of the facility was empty and what equipment remained was either disassembled or inoperable. During my closing meeting with Joe, Jamie Noviss with SAF and Sara Meyer their consultant with ERM met with me. Sara was on site to close out all relative permits. I informed Sara that the permits should be voided since the equipment has been uninstalled.

Conclusion

SAF Holland is no longer operating and had ceased operations on October 31st 2017. The facility will be completely closed at the end of 2017. It appears that SAF Holland is in compliance with the Federal Clean Air Act Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act of 1994, PA 451, as amended, Michigan's Air Pollution Control Rules and PTI No. 194-14. The permitted processes are no longer functional and/or installed at the facility and facility's permit No. 194-14 will be voided upon request of the facility representatives.
