## **VIOLATION NOTICE**

On July 6, 2017, the Department of Environmental Quality (DEQ), Air Quality Division (AQD), conducted an inspection of Ervin Amasteel Division (Company) located at 950 Tabor Street, Adrian, Michigan. The purpose of this inspection was to determine the Company's compliance with the requirements of the federal Clean Air Act; Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (Act 451) and the associated Air Pollution Control Rules and your Renewable Operating Permit (ROP) No: MI-ROP-B1754-2013.

During the inspection, AQD staff observed the following:

Please initiate actions necessary to correct the cited violations and submit a written response to this Violation Notice by August 15, 2017. The written response should include: the dates the violations occurred; an explanation of the causes and duration of the violations; whether the violations are ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violation and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence.

If the Company believes the above observations or statements are inaccurate or do not constitute violations of the applicable legal requirements cited, please provide appropriate factual information to explain your position.
