SECOND VIOLATION NOTICE

On June 15, 2017, the Department of Environmental Quality (DEQ), Air Quality Division (AQD), conducted an inspection of Hot Line Cleaners, 1849 East 7 Mile Road, Michigan. The purpose of the inspection was to determine Hot Line Cleaners' compliance with the federal National Perchloroethylene Air Emission Standards for Dry Cleaning Facilities, Title 40 of the Code of Federal Regulations (CFR), Part 63, Subpart M and the Public Health Code, 1978 PA 368, as amended, Dry Cleaning Establishment Rules Utilizing Class I, II, III, and IV Solvents.

On June 21, 2017, the AQD sent the company a Violation Notice citing violations discovered as a result of the inspection and requested your written response by July 12, 2017. A copy of that letter is enclosed for your reference. As of this date, we have not received your response.

Please be advised that failure to respond in writing and identifying actions the company will take or has taken to resolve the cited violations may result in escalated enforcement action by the AQD. Please provide the information requested in our June 21, 2017, letter by July 31, 2017, which corresponds to 14 days from the date of this letter.

Be further advised that issuance of this Violation Notice does not preclude or limit the DEQ's ability to initiate any other enforcement action under state or federal law as appropriate.
