

VIOLATION NOTICE

On November 25, 2024, the Department of Environment, Great Lakes, and Energy (EGLE), Air Quality Division (AQD), investigated complaints of nuisance odors in the vicinity of Woodland Meadows RDF located at 5900 Hannan Rd., Wayne, Michigan. The purpose of this investigation was to determine Woodland Meadows RDF's compliance with the requirements of the federal Clean Air Act; Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (Act 451); the Air Pollution Control Rules; and the conditions of Renewable Operating Permit (ROP) number MI-ROP-M4449-2024, Section 1.

AQD staff performed an investigation from approximately 10:10 PM to 10:45 PM on November 25, 2024. During this investigation, AQD staff observed the following violation:

R 336.1901(b) states, in part:

"A person shall not cause or permit the emission of an air contaminant in quantities that cause injurious effects to human health and property, or the unreasonable interference with the comfortable enjoyment of life and property."

During the investigation on November 25, 2024, AQD staff detected moderate to strong sour hydrogen sulfide/landfill gas-type odors in residential areas downwind of Woodland Meadows RDF which were determined to be attributable to the facility's operations. In the professional judgment of AQD staff, the odors observed were of sufficient intensity

and duration so as to constitute a violation of R 336.1901(b) and General Condition 12(b) of ROP No. MI-ROP-M4449-2024, Section 1.

Please initiate actions necessary to correct the cited violation and submit a written response to this Violation Notice by December 26, 2024 (which coincides with 21 calendar days from the date of this letter). The written response should include: the date the violation occurred; an explanation of the causes and duration of the violation; whether the violation is ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violation and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence.

If Woodland Meadows RDF believes the above observations or statements are inaccurate or do not constitute violations of the applicable legal requirements cited, please provide appropriate factual information to explain your position.
