AmCane Sugar LLC: Inspection

On May 28, 2020, I arrived at the premises of the AmCane Sugar LLC at 1130 hours. The purpose of this visit was to conduct a surveillance on the facility's operation status and emission compliance. The EGLE-AQD had been in communication with the AmCane Sugar facility for 3 years regarding the resolution of previous violation notices issued to the Company. The conversations between the EGLE-AQD and AmCane Sugar LLC regarding the violations and necessary compliance resolution is captured in the Appendix A.

Summarily, the AmCane Sugar LLC submitted to the EGLE-AQD that the violation issues regarding the boiler stacks were resolved and the company was prepared to set up a stack testing session for compliance. According to the facility manager, John Cieslowski, a testing consultant was contacted for the testing service and negotiations were underway. The lockdown and quarantine order slowed compliance pursuit activities at the facility as confirmed by on-site surveillance conducted in March 2020. I wrote to the AmCane Sugar management requesting an update on the progress of testing arrangements. Staff received no response. Spurred by the media publications that AmCane was closing its operations on March 1, 2020, I made follow up phone calls to the management and left voicemail messages requesting updates. Up to the time of reporting, the AQD has not received the updates requested.

Summarily, based on conversations listed in the Appendices, I visited the facility on May 28, 2020 to ascertain the facility's operation status. I observed activities going on at the facility. There were bands of crews cleaning the inside of the facility and feeding the trailer bin located in one of the bay doors. No unusual odor was detected in the cleaning and binning area.

I observed the stacks were not active. The stacks exit points indicated zero opacity. I noticed the cooling tower water was in operation, however the system fan was being idled without a duty load. I drove around the facility and observed the technical contractors were entering and leaving the building using the back doors. There were several Palmer Inc. mover-vehicles parked in front of the building. None of the crew members seen on the site wore a Covid19 PPE. I did not exit my vehicle or engage anyone at the site. I left the area at 1240 hours.

I called the facility phone from my vehicle. The voicemail recording device activated. I left a message for John Cieslowski to return my call. I followed up with an email message to John after I returned to my work computer. The email message bounced back undelivered. The appended return message from the SOM OUTLOOK mail system informed the email addresses were not active.

In conclusion, the AmCane Sugar facility did not confirm if the facility is operational or closed to business at the location. Further visits are planned for confirmation. Further google search indicated that Michigan Sugar advertised open positions for their plants located at several sites. However, the Taylor location was not listed among the Company sites.
