Permit 374-87I is an active permit in AQD's files. The permit authorizes a concrete batch plant. In 2009 AQD staff inspected the site. In 2009 there was communication from Bonnie Nagy indicating the concrete batch plant had been out of operation for several years. AQD did not receive a request to void permit 374-87I.

A concrete batch plant can have a variety of parts including: mixers, cement batchers, aggregate batchers, conveyors, radial stackers, aggregate bins, cement bins, heaters, chillers, cement silos, batch plant controls, and dust collectors (to minimize environmental pollution).

Recently Gloria Torello and Becky Radulski of AQD staff went to the site found at 1988 Levering Road. Staff knocked at the door of the small white building, but there was no answer. The load-out structure and hopper referenced in the 2009 activity report are no longer on site. AQD staff saw two semi-trailers, and a smaller trailer onsite. The trailers had the following text on a label: Nagy Property Maintenance 727-808-9538.

AQD staff also saw a pit approximately 30 feet in diameter and approximately 3 feet below grade. In the pit was evidence of burned construction/demolition debris including charred wooden boards, brick and concrete blocks, and tree stumps. Some of the cement and brick blocks are protruding from the dirt in the pit indicating burying of construction/demolition debris may also occur on site. In a pile adjacent to the pit is construction/demolition debris including 2x4 boards, dry wall, insulation, and brush. In different piles adjacent to the pit are piles of broken asphalt. Photos were taken.

On July 23 & 24, 2014, Torello spoke with City of Cheboygan Director of Public Safety Chief Kurt Jones. The property is outside of the Cheboygan City limit.

On July 30, 2014 Torello left a message at 627-808-9538 regarding burning of construction debris at the Nagy property on Inverness Road. Later in the morning Jim Nagy called back. Mr. Nagy said in the spring 2014 the DNR ticketed him for open burning and questioned how DEQ could continue to pursue the same issue, Torello said she worked for the DEQ not the DNR. Mr. Nagy said the pile of 2x4s, dry wall, and insulation are his materials and stated he could store his material on his property. Torello said there are regulations for proper disposal of waste, which Mr. Nagy questioned. Torello said a letter would follow. Later in the morning Mr. Nagy also spoke with Janis Ransom, DS AQD.

On July 30, 2014 Torello spoke to DNR CO Matt Theunick. The CO said in April 2014 he issued a ticket to James Nagy for open burning construction debris and brush. The CO said the Mackinac County prosecutor, with the work of Mackinac County Deputy Sherif Graham Whipple, are prosecuting Mr. Nagy for burning construction and demolition on Bois Blanc Island.

AQD staff will send Mr. Nagy a letter notifying him of AQD's open burning rule, and of Section 115 of Act 451, which prohibits the disposal of solid waste other than at a licensed solid waste disposal, recycling, or composting facility. A request to void the permit can be sent to the AQD.
