Inspection Summary

On 3/3/16, I contacted Dave Wakeland by phone and informed him that this site identified by the RRD spill database as Facility ID 00015390 and Leak ID C-004-85 was still showing as an "open" site with an active air permit. He informed me that the site remediation had been complete to his knowledge and all free product was removed around 2005-2006. The rented remediation equipment was removed shortly thereafter. I informed him that I would visit the site and confirm the removal of the equipment thus allowing me to void the permit; though action by him was needed to close the site with RRD.

I visited the location on 3/4/16, the site is a BP gas Station / convenience store under different ownership. I spoke with the cashier Diane and she allowed me to walk the property and enter buildings associated. I confirmed the remediation device has been removed.

This report will be used to void Permit To Install 289-03. A copy of the voided permit will be sent to Wakeland Oil Company and the current owner of the property.
