## VIOLATION NOTICE

On May 19, 2023, the Department of Environment, Great Lakes, and Energy (EGLE), Air Quality Division (AQD), finalized Consent Order AQD number 2023-13 with Minth Group LTD. The Compliance Program and Implementation Schedule section of the Consent Order (ACO) outlines records which Minth Group LTD shall submit to the AQD. Upon review of records received, the AQD alleges violation of the following:

EUCOATING	Consent Order AQD number 2023-13, Paragraph 10.	Quarterly report for Q2 2024 was not provided within thirty (30) days following the end of the full calendar quarter in which the data was collected.

Paragraph 10 of Consent Order AQD number 2023-13 states the following, "The Company shall submit four (4) quarterly reports containing records as described in EUCOATING, Special Conditions VI.4, VI.5, VI.6, and VI.7 of PTI No. 119-20, as amended, to the AQD Bay City District Supervisor. On and after the Effective Date of this Consent Order, each quarterly report is due within thirty (30) days following the end of each full calendar quarter in which the data were collected."

AQD records indicate a total of three (3) quarterly reports satisfying the requirements of paragraph 10 were received. These reports include records for the periods quarter 3 2023, quarter 4 2024, and quarter 1 2024. A quarterly report for quarter 2 (Q2) 2024 was received on October 25, 2024. The deadline for the Q2 2024 report was within thirty (30) days following the end of Q2 2024, which was July 30, 2024.

Please initiate actions necessary to correct the cited violation and submit a written response to this Violation Notice by November 20, 2024 (which coincides with 21 calendar days from the date of this letter). The written response should include: the dates the violation occurred; an explanation of the causes and duration of the violation; 401 KETCHUM STREET • SUITE B • BAY CITY, MICHIGAN 48708

whether the violation is ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violation and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence.

If Minth Group LTD believes the above observations or statements are inaccurate or do not constitute violations of the applicable legal requirements cited, please provide appropriate factual information to explain your position.
