RESOLVED COMPLAINTS:			

I (glm) conducted a scheduled inspection at Hensler Furniture Refinishing Inc. on December 1, 2014. I met with Mr. Brian Hensler, owner. The facility is operated under the approved PTI 176-94A. At the time of my inspection the facility was in compliance with its permit and applicable air quality regulations.

I arrived at the facility around 10:30 A.M. Hensler Furniture Refinishing repairs, strips and finishes wood furniture of which is mostly antiques. The permit covers the stripping operation which consists of a small soak tank and a stripping machine. For regulation purposes the facility is considered a minor source of VOCs. The spray booth is exempt from permitting via R287(c). Other operations consist of woodworking, which is captured through an exhaust bag and is not exhausted externally.

## **Compliance Determination**

At the time of my inspection the spray booth had the appropriate filters in place as well as HPLV spray guns. The facility used 206 gallons, total, of lacquers, stains and finishers to date for the year. This is well below the monthly 200 gallon limit in R287(c).

The records show the actual emissions are well below the VOC limits of 12.4 TPY. Material usage limits for the stripping solvent are also well below the permitted 3,575 gallons.
