This site identified by the RRD spill database as Facility ID 00005712 and Leak ID C-0526-93 and was showing as a "closed" site with an active air permit. I was unable to find a contact person for the permit, so I performed a site visit to confirm the equipment had been removed and I could void the permit.

I visited the location on 3/4/16, the site is a BP gas Station / convenience store under different ownership. I spoke with the cashier Diane and she called the current renter, Yaser Berry. Yaser informed me that he was a renter and that Armada Oil and Gas Company was the current owner. He provided me the address for the company and confirmed that a remediation device was not on the property.

This report will be used to void Permit To Install 491-94. A copy of the voided permit will be sent to Armada Oil Company and the current renter of the property. Since current information for Amoco Oil Company is not available, notification will not be completed.
