VIOLATION NOTICE

On November 27, 2017, the Department of Environmental Quality (DEQ), Air Quality Division (AQD), conducted an inspection of portable crushing plant owned/operated by Hanlee Equipment LLC/Briggs Contracting, Inc.(Company) located at 5405 East Michigan Avenue near Jackson, Michigan. The purpose of this inspection was to determine the Company's compliance with the requirements of the federal Clean Air Act; Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (Act 451) and the associated Air Pollution Control Rules and General Permit to Install (PTI 453-99).

During the inspection, AQD staff observed the following:

Process Description	Rule/Permit Condition Violated	Comments
FGCRUSHING	PTI 453-99 Special Condition (SC) 1.7	Each screen shall be equipped with a water spray bar.
FGCRUSHING	PTI 453-99 SC 1.2	Visible emissions from the crusher were more than 15%. The water spray bars were not being used. The crusher was crushing concrete at the time.

Please initiate actions necessary to correct the cited violations and submit a written response to this Violation Notice by December 28, 2017. The written response should include: the dates the violations occurred; an explanation of the causes and duration of the violations; whether the violations are ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violation and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence.

If the Company believes the above observations or statements are inaccurate or do not constitute violations of the applicable legal requirements cited, please provide appropriate factual information to explain your position.

Thank you for your attention to resolving the violations cited above and for the cooperation that was extended to me during my inspection of this Company.
